1. Scholarship shall be awarded for one academic year.
2. The scholarship will be awarded to BE/BTech. 1st year student(s) of any stream. To continue this scholarship, a student has to score CGPA \geq 7.5 with no E or F or X grade in the relevant academic year.
3. The student should have scored not less than 80% marks in 12th class and atleast 40% marks in JEE Main.
4. Scholarships shall be awarded to the students whose parents' gross income should not exceeds Rs. 5.00 lacs per annum. The income criterion should also be satisfied for the continuation.
5. The information provided by the applicant for availing the merit-cum-means scholarship can be verified by the committee at any point of time. If any information found false, scholarship will be withdrawn and disciplinary action will be taken against the student.
6. The right of awarding the scholarship shall lie with the award committee.

Students applying for IM Thapar scholarship will attach the following certificates/documents:

1. Proof of JEE (main) Rank for BE/BTech. 1st year student and CGPA in case of other years students.
 2. A copy of DMC of 12th class.
 3. Proof of annual family income in the form Income Certificate issued by revenue official /copies of Income Tax returns for last three years filed by the parents.
 4. The parents shall be required to submit an affidavit of their annual family income from all the sources and should also mention the source of income duly verified by the notary.
 5. A copy of fees receipt paid by the student for current semester.
