Subject: POST MATRIC SCHOLARSHIP TO SC STUDENTS FOR THE YEAR 2017-18

Applications are invited **on line for POST MATRIC SCHOLARSHIP for SC** students whose **family income is less than Rs. 2,50,000/- P.A.** Eligible students are required to visit site www.punjab scholarships.gov.in and fill up the application forms after getting themselves registered. Date of submission the applications and other guideline are mentioned on the www.punjab scholarships.gov.in . Students are advised to submit the print out of application form alongwith relevant and following documents in the office adjoining the office of Dean, Student Affairs (Room No.AB-106) at the earliest latest by 24th October, 2017* on any working day during students hour i.e. 11.30 AM to 12.30PM and 3.30. PM to 4.30 PM so that applications may be forwarded in time. **The last date of online submission of application is 24th October 2017. Students can apply only for one scholarship of any government agency only.**

An application for POST MATRIC SCHOLARSHIP should comprise:

1. A Certificate (in original) of Caste duly signed by an authorized Revenue Officer not below the rank of Tehsildar for fresher and attested copy for renewal case.
2. A Residence certificate (in original) duly signed by an authorized Revenue Officer not below the rank of Tehsildar for fresher and attested copy for renewal case.
3. An income certificate duly signed by an authorized Revenue Officer not below the rank of Tehsildar. A self declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income, from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper.
4. Attested copies of certificates - Matriculation, Diploma/Degree etc. in respect of all examination passed.
5. One copy of the passport size photograph of the student thereon.
6. A copy of first page of bank pass book of the student having bank account no. IFSC code.
7. A copy of Aadhaar Card linked with bank account.
8. Hostlers are required to submit the certificate from the hostel authority.
9. An undertaking that student has not applied/availed any other scholarship during the current financial/academic year.
10. Students will submit the attendance of previous year - course wise alongwith the names of teachers concerned with their mobile Numbers. Students will also submit their courses for the current session alongwith names of teachers concerned with their mobile numbers and e-mail.

Note: Minimum 75% class attendance is required to avail the scholarship.
