Notes:

1. In case any of the course (listed in Minor in CS) is in the regular scheme of courses as a 'compulsory course' of any branch, then the students of that branch need not to study that course in Minor in CS.
2. In case any of the course (listed in Minor in CS) is in the regular scheme of courses as an 'elective course' of any branch, then the students of that branch will have to study that course in Minor in CS. The student will have to study some other course as an elective (other than the course in Minor in CS) to be considered for completion of credits for his branch.
3. The CSE or related branches i.e., CSE, COE, CSBS, ENC, EEC etc., are not eligible for 'Minor in CS'.
